Elections as an exercise of democracy. Elections also serve as a means of realizing democracy. Leadership elections occur at the central level, where state leaders are elected, as well as at the regional level, where governors are chosen and deputy governor, as well as at the district level electing the regent and deputy regent or mayor and deputy mayor. - 1. Political parties, (1) through elections elect officials who are formally and informally responsible for state policy; (2) is free from intervention from other parties: (3) has broad support from the community; and (4) rely on leadership that is trusted by its members and is capable of leading the country;
- 2. General agreement (consensus) regarding; (1) the rules of the political game, both formal and informal, concerning the decision-making process; (2) consensus regarding the economic, social and cultural values that society wants to achieve/maintain;
- 3. The executive institution determines (domain) the government decision-making process;
- 4. State bureaucracy that is able to implement government policies (Isra & Fahmi, 2021)

It cannot be denied that welfare will be influenced by the politics of leaders produced through general elections which are of course carried out properly and correctly. Which also prioritizes the one person, one vote, one value system. (one person, one voice, one value) which will determine the direction of development prosperity.

Democracy as a constitutional concept in its use as a state ideology has many meanings and names, this is due to the large number of implementations of democratic values which seem to be the obsession of people in the world. By implementing democratic values and systems in the country, stability in various fields can be achieved. The four stages of development planning as stated in the Law of the Republic of Indonesia Number 25 of 2004 concerning the National Development Planning System article 8 are:

- 1. Preparation of the Plan, carried out in 4 steps, namely: (1) Preparation of a development plan that is technocratic, comprehensive and measurable; (2) Each government agency prepares a draft work plan that is guided by the development plan that has been prepared; (3) involving the community (stakeholders) and harmonization through musrembang at each level; (4) Preparation of the final draft development plan.
- 2. Determination of the Plan, which becomes a legal product of the Long-Term, Medium or Annual Development Plan;
- 3. Controlling the implementation of the plan, namely to ensure the achievement of the development goals and objectives stated in the plan through correction activities and analyzing the results of monitoring the implementation of the development plan by the head of the institution or ministry;
- 4. Evaluation of plan implementation, namely systematic activities to collect and analyze data and information to assess development achievements, targets, objectives and performance. which is based on indicators and targets that include input, output, results, benefits and impacts of development planning by the head of an institution or ministry.

### CONCLUSION

General elections hold an important meaning in people's sovereignty, especially in terms of democracy. Because in the general election it is hoped that national leaders will be created who will take an interest in development for the welfare of society. Every election participant's vision and mission should prioritize creating development for the welfare of society.
